



Missouri Common Grant Application V.2.0 Grantmaker Information

Updated November 2017



The Missouri Common Grant Application (CGA) Version 2.0 allows grantmakers and grantseekers to work from a common set of questions and definitions that reinforce solid nonprofit practices. The following Missouri grantmakers use the CGA, or parts of it, in their application processes. It is important for grantseekers to note that grantmakers may use the CGA Version 1.0 or 2.0, modify parts of the CGA for their purposes, or elect to use only some elements of the CGA and not others. *As such, grantseekers should download application materials directly from specific grantmaker websites.*

Grantseekers should contact grantmakers directly for information about strategy, and for questions about the specific application process and forms used by each foundation.

ARCHS

Mission

To improve the lives of Greater St. Louis' residents by convening strategic community partnerships.

Grant Deadlines

ARCHS does not have free standing funds to allocate. ARCHS issues formal requests for proposals (RFPs) for specific program funding.
